

## TeacherLists List it for a Library Sweepstakes | Official Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED BY LAW. ONLINE ACCESS REQUIRED.

Sponsor: The sponsor of the 2020 List it for a Library Sweepstakes (the "Sweepstakes") is TeacherLists (School Family Media, LLC.) with offices located at School Family Media LLC, 100 Stonewall Blvd. Suite 3, Wrentham MA 02093 ("Sponsor"). With respect to this Sweepstakes, affiliates of Sponsor include Scholastic Inc. and each of their respective affiliated companies, parent companies, subsidiaries, suppliers, distributors, prize suppliers, advertising and promotional agencies, and each of their respective officers, directors, employees and agents ("Affiliates").

- **1. Sweepstakes Dates**: The Sweepstakes begins April 7, 2020 at 12:00:00 AM Eastern Time and ends June 30, 2020 at 11:59:59 PM Eastern Time ("Sweepstakes Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
- 2. Eligibility: Subject to the additional restrictions in these Official Rules, the Sweepstakes is only open to registered TeacherLists users who are legal residents of the fifty (50) United States and the District of Columbia and at least 18 years or older at the time of entry, and who meet entrant requirements (see section 4 in "official rules"). Each entrant is entering the Sweepstakes on behalf of his/her respective schools. Void where prohibited by law. Employees of Sponsor, Affiliates, and the immediate family members of, and any persons domiciled with any such persons, are not eligible to enter. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

- **3. Participation**: Participation constitutes your full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements as set forth herein. Sponsor and its Affiliates are not liable for any injury or damage to your or any other person's computer or its contents relating to or resulting from participating in or downloading any materials concerning this Sweepstakes, or from other technical difficulties, failures or other errors of any kind. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes, as solely determined by Sponsor. In the event that the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupt or impair the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prize based on the non-suspect, eligible entries received before the termination date.

- **4. How To Enter**: During the Sweepstakes Period, registered TeacherLists users can enter for a chance to win on behalf of their respective schools by following the details outlined on the sweepstakes landing page, <a href="www.teacherlists.com/list-it-for-a-library">www.teacherlists.com/list-it-for-a-library</a>. Complete in full all of the required information, including submitting eligible school supply lists and follow all posted instructions to submit your entry. You need to have or sign up for a free account with TeacherLists.com. Registration is free. No purchase or pledge required to enter.

For a school to qualify as an entrant in the sweepstakes:

a) A representative of the school (for example, school secretary, PTO leader) may set up his or her own TeacherLists account, and use TeacherLists to post at least

- four (4) new or updated for 2020-2021 individual classroom school supply lists for (4) individual teachers who are currently employed at the account registrant's school, and each list must contain a minimum of four (4) items, or, b) Individual teachers at the same school may set up their own individual.
- b) Individual teachers at the same school may set up their own individual TeacherLists.com user accounts and use TeacherLists.com to publish their own new or updated for 2020-2021 individual classroom supply lists for the school they are currently employed at, with a minimum of four (4) items on each list, in which case a school then qualifies once it has a minimum of four (4) new or updated for 2020-2021 individual classroom supply lists on TeacherLists.
- **5. Limitations on Entry**: Grand prize entries limited to one (1) entry per school, with a minimum requirement of 4 lists per school. Potential winner may be required to provide valid and legal proof of identification. All entries must be fully and accurately completed. Use of any automated system to participate in the Sweepstakes or subvert the entry process is prohibited and will result in disqualification and all associated entries will be void.

Sponsor and Affiliates are not be responsible for incomplete, inaccurate, illegible, unintelligible, damaged, lost, late, postage-due, misdirected, delayed or stolen entries or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize or in any Sweepstakes-related materials. In the event of a dispute of who submitted an online entry, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent and he/she must comply with these Official Rules. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the Internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account. Any questions regarding the number of entries submitted or the owner of an ISP account shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right

to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes. All entries become the property of Sponsor and will not be acknowledged or returned.

**Prize and Odds**: Ten (10) winners will receive the prize for their respective school or classroom: a Classroom Library from Scholastic for teacher/school staff member in whose name the TeacherLists account is under ("Winning Teacher/School"). Approximate Retail Value of Sweepstakes Grand Prize: \$499.

The odds of winning depend on the number of eligible entries received. Prize is non-transferable, non-exchangeable, and has no cash value to Winner. No cash substitutions. If prize becomes unavailable or at Sponsor's sole discretion, Sponsor may award substitute prize of comparable or greater value. Prize will be received before December 31, 2020. All prize details are at Sponsor's sole discretion. Limit one grand prize per school. Prize will only be provided to applicable school with school's consent. In the event a school does not consent to receive the prize, an alternate winner will be selected.

6. Winners Drawing, Notification, and Acceptance: Ten (10) potential Winners will be selected from all eligible entries received during the Sweepstakes Period in a random drawing to be held by July 18, 2020. Potential Winners will be contacted during Sponsor's regular business hours at the applicable email addresses or phone number associated with the TeacherLists accounts that they confirmed at time of entry. Failure to reach a potential Winner by email after three (3) attempts may result in the disqualification of that potential Winner and forfeiture of his or her interest in the prize. Sponsor will, at its sole and absolute discretion, be free to select an alternate potential Winner from among all remaining eligible entries. Any potential Winner may waive his/her right to receive a prize. Winners are solely responsible for reporting and payment of any and all taxes on prize received, if applicable. Potential Winners may be required to complete an Affidavit of Eligibility/Liability and Publicity and Prize Release ("Affidavit") (except where prohibited by law) which must be returned as directed by Sponsor in order to claim the prize.
